Manager and Owner mutually agree to the following:

1. Morning Drop off/ Pick up time is 7:30am-8:30am.
2. Evening Drop off/ Pick up time is 5:30pm-6:30pm.
3. Owner agrees that the Manager is not liable for death, sickness, and/or accident including consequential damages caused to the dog while in the Managers possession, except if caused by the wilful and wanton negligence of the Manager.
4. Manager has the authority to contact a veterinarian for emergencies care. The manager in its sole discretion may engage the services of a veterinarian, give medicine or medical attention, and the expenses thereof shall be paid by the owner. _____ (owners' initials). If the cost is to exceed \$_____ Owners must be contacted first. If owners can't be reached the Manager is authorized to make a decision based on veterinarian recommendation up to \$_____.

- Three Dogs – Single Stall - \$40 per 24 hr period
- Day Care – \$20/day/dog (Between 8am – 5pm)

6. Dogs Health

- a. The dog shall be free of infectious, contagious, or transmissible disease. If the owner's dog is found to be infectious and failed to inform the manager, and other boarded dogs become infected with the same symptoms, the owner of the infectious dog will be held liable for any and all veterinarian bills that result from the transmission of the disease or parasite.
- b. Current Rabies, Da2pp and Bordetella must be up to date and noted in a current logbook accompanying the dog.

No other agreements or promises, verbal or implied are included unless specifically stated in writing.
